Illinois Agri-Women Host "Women Changing the Face of Agriculture"

Over 650 high school and college students gathered at the 11th annual career discovery event "Women Changing the Face of Agriculture" (WCFA 2020) on Friday, March 5, 2020, at Richland Community College in Decatur, Illinois. The 45 supporting companies, agricultural agencies and organizations set up booths in the career fair and activities for the hands-on breakout sessions. Students had an opportunity to learn more about the companies and the career tracks that the women have experienced. A very hearty **THANK YOU!!!** to all of the Illinois Agri-Women, professional associates and college students that assisted with preparations and hosting duties for the event. It wouldn't happen without the team effort that is necessary for such a large undertaking.

Michelle Miller or Farm Babe, social media influencer from an Iowa farm, shared information with the students on Friday about her journey from fashion designer to sharing her daily activities on the farm. Farm Babe also shared suggestions with over 80 agriculture professional women on Thursday evening prior to WCFA 2020 during a networking and professional development session on the potential power that each of us has to raise awareness and educate others about agriculture.

The Full Circle initiative was highlighted during WCFA 2020, as the students were introduced to several of the women representing career tracks at the event. The Full Circle women are those that attended "Women Changing the Face of Agriculture" as a student over the past 10 years, have completed their college education and are now employed at one of the supporting companies or agencies. The search for more Full Circle representatives continues and will be recognized at future IAW events.

The Scholarship Committee has completed its selection process and determined Kylie Miller will receive the Helen Henert Memorial Agricultural Education scholarship of \$1,500. Ashley Althaus was named the high school student WCFA Agent of Change winner, Kelli Black and Callie Wildman were named the graduate student WCFA Agent of Change winners, and 20 additional college students were named the Company Sponsored Match Scholarship winners. These 23 young women each received a \$1,000 scholarship.



Illinois Agri-Women 2020 Award Nominations Being Accepted

Illinois Agri-Women celebrate their long history by recognizing members who have made significant contributions to the agriculture community and our organization. As has been the practice for numerous years, the Illinois Department of Agriculture has allowed agriculture trade associations and commodity groups to recognize annual award winners on Ag Day at the Illinois State Fair.

The last three years, the IDOA has limited these groups to one award per entity to be announced during the ISF Ag Day festivities. Illinois Agri-Women have chosen to recognize our annual Hall of Fame Winner at the state fair followed by a formal presentation of the annual winners at the next annual meeting. As we all are aware the Covid-19 Pandemic has altered the way our August will look in 2020 with the absence of the Illinois State Fair.

However, your IAW Awards Committee will proceed as we normally would and accept nominations for the following awards: Hall of Fame, Outstanding Business Woman and Outstanding Farmer to be recognized at the 2021 Annual Meeting.
